**SERVICES:**

a. For an Alcohol and other Drug (AOD) Assessment ..... (CHECK if applicable)

- The AOD assessments (approximately 2 hours) are conducted at the Service Center located at 5501 Airport Blvd., Suite 102 (map#1 on back). Monday through Thursday from 7:30am to 3:30pm or Friday 7:30am to 11am. **No appointment is necessary.** Cost of AOD assessment is \$55.00 due at the time of assessment.
- **BRING THIS REFERRAL FORM WITH YOU. Bring any other paperwork related to your offense with you i.e., Probation Papers; Bond release paperwork; Protective Order, etc.**

b. For a Family Violence (FV) Assessment ..... (CHECK if applicable)

- The FV assessments (approximately 2 1/2 hours) are conducted at the Intake Office located at 1010 Lavaca, 2<sup>nd</sup> floor (map#2 on back). Monday through Thursday from 7:30am to 2:30pm or Friday 7:30am to 11am. **No appointment is necessary.** Cost of FV assessment is \$55.00 due at the time of assessment.
- **BRING THIS REFERRAL FORM WITH YOU. Bring any other paperwork related to your offense with you i.e. Probation Papers; Bond release paperwork; Protective Order, etc.**

c. For CES Classes ONLY (Write in choice from Class Menu on the back)..... (CHECK if applicable)

- **Call (512) 854-9540 (M-F, 8-5 p.m.) within 24 hours of receipt of this form to schedule services at CES.** If registering for an education or youth class only, you will be scheduled into the class at the time you call CES. All education class fees are payable at the time of your class. A completion certificate will be issued to you at the end of the class if all fees have been paid. 

**North Austin:** Take IH-35 South (south bound). Take the 51<sup>st</sup> Street exit. When you get to 51<sup>st</sup> street take a right, you will continue until you get to Airport Blvd. When you get to Airport Blvd take a right, continue until you pass 53<sup>rd</sup> street. Once you pass the light at 53<sup>rd</sup> street you will see the Travis County Building on your right hand side. Counseling & Education Services is in Suite #102.

**From South Austin:** Take IH-35 North (north bound). You will need to take the upper deck where IH 35 splits. Take the Airport Blvd. exit. When you get to Airport Blvd take a left, continue about 1 mile until you pass 53<sup>rd</sup> street. Once you pass the light at 53<sup>rd</sup> street you will see the Travis County Building on your right hand side. Counseling and Education Services is in suite #102.

**From North Austin:** Take IH-35 South (southbound). Take the 11<sup>th</sup> – 12<sup>th</sup> Street exit. Stay on the frontage road, turn right on 10<sup>th</sup> Street and continue on 10<sup>th</sup> Street until you get to Lavaca St, take a right. The Intake office will be on your left hand side. **Metered parking only.**

**From South Austin:** Take IH-35 North (northbound). Take the 6<sup>th</sup>-12<sup>th</sup> exit. Turn left on 8<sup>th</sup> Street and continue on 8<sup>th</sup> Street until you get to Lavaca St, take a right. The Intake office will be on your left hand side past 10<sup>th</sup> St. **Metered parking only.**
