## TRAVIS COUNTY FIRE CODE FEE STRUCTURE

OPERATIONAL PERMITS		
Permit fees must be paid when the permit application is submitted. The Travis County Fire Marshal's Office can accept a business check, money order or cashier's check. Please make checks payable to the Travis County Fire Marshal's Office.		
PERMIT	SCOPE	PERMIT FEE
<b>Carnivals and Fairs</b>	An operational permit is required to conduct a carnival or fair.	<b>\$240.00</b>
<b>Public Fireworks Display</b>	An operational permit is required to conduct a fireworks display. Plans must be reviewed, the site must be visited and approved and revisited immediately before the event. Records of the event and permitting must be maintained. Some public displays require a marshal or inspector on scene during the display.	The fee is determined by time required to issue the permit at the rate of <b>\$60.00</b> per hour with a five-hour minimum. Travel time will be incorporated when calculating this fee. Displays requiring standby: billed at the off-duty contract rate of \$60.00 per hour. The hourly rate is applied for each fire marshal required for the event.
<b>Fireworks Stand</b>	An operational permit is required to operate a firework stand.	<b>\$208.00</b> per stand.
<b>Special Event (Mass Gathering and Special Assignments)</b>	An operational permit is required to conduct a special event. Special events include a mass gathering, as defined in the State of Texas Health and Safety Code, and other events where a public safety plan is required by the Fire Marshal.	The fee is <b>\$360.00</b> for a single day event. The fee is <b>\$420.00</b> for events of two or more days. Fire Marshals performing event inspections and public safety standby at site are billed at the off-duty contract rate of <b>\$60.00</b> per hour. The hourly rate is applied for each fire marshal required for the event. Travel time will be incorporated when calculating these fees.
<b>Special Permit</b>	This fee covers the review and inspection of permitted activities not addressed elsewhere in this fee schedule.	<b>\$240.00</b>
<b>Hazardous Materials</b>	A Hazardous Materials facility or system.	<b>\$360.00</b>
<b>Tank Abatement</b>	To remove, or abandon in place, an aboveground or underground storage tank designed to contain compressed gases, cryogenic fluids, flammable or combustible liquids, hazardous materials or LPG.	<b>\$120.00</b> per tank

### OPERATIONAL PERMIT SERVICE FEES

Service fees must be paid before the service is scheduled.  
 The Travis County Fire Marshal's Office can accept a business check, money order or cashier's check.  
 Please make checks payable to the Travis County Fire Marshal's Office.

SERVICE	SCOPE	SERVICE FEE
<b>After Hours Inspection</b>	This fee covers inspections conducted at the request of a contractor, an applicant or owner's representative, at times other than normal working hours. Normal working hours range from 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding County holidays.	An after-hours inspection is billed at <b>\$90.00</b> per hour with a two-hour minimum. Travel time is incorporated in calculating this fee.
<b>Duplicate Permit</b>	This fee covers the issuance of duplicate permits.	<b>\$10.00</b>
<b>Pre-Development Review</b>	A pre-development review includes meetings, site visits, and other functions conducted prior to formal submission of construction plans.	The first two pre-development functions will be conducted at no charge to the project. Additional meetings will be billed at <b>\$60.00</b> per hour. Travel time will be incorporated when calculating this fee.
<b>Reinspection</b>	This fee covers reinspection of any site, building, or retest of any system, due to failure of the previous inspection or test. A reinspection will also be required when approved plans are not on-site at the time of the scheduled inspection.	Reinspection will be billed at <b>\$60.00</b> per hour with a two-hour minimum. Travel time is incorporated in calculating this fee.
<b>Rescheduling</b>	This fee is required when an appointment for an inspection is cancelled less than 4 hours prior to the appointment time.	<b>\$60.00</b>
<b>Standby Personnel</b>	This fee covers the cost of providing fire marshals to perform required public safety functions during large special events.	Fire Marshals performing required inspections and public safety standby at event site are billed at the off-duty contract rate of <b>\$60.00</b> per hour. The hourly rate is applied for each fire marshal required for the event. Vehicles assigned are calculated at the County rate of <b>\$20.00</b> per hour with a two-hour minimum.
