Office of Children Services	Community Partners for Children	Is a single place for collaboration for children and youth with complex behavioral health needs and their families. CPC works to: create a barrier-free process for families to access community resources, increase family involvement at all stages of intervention, decrease the duplication of efforts for children and youth with complex needs, create one community voice supporting an individualized plan of care for each youth and to utilize flexible funds in the development of innovative strengths-based plans of care.
Office of Children Services	The Children's Partnership	Provides services and supports to families of children and youth with complex behavioral health needs. Staff partner with families and develop individualized plans of care that build on the strengths of the child, the family, and the team. The program utilizes the Wraparound service model and integrates the System of Care values into service delivery.
Office of Children Services	System of Care Flexible Funding	Facilitates access to services that address the mental, developmental, and behavioral health needs of children, youth, and their families. Service choice is driven by the family and is individualized to the unique needs of their family. The service continuum is diverse and includes a variety of service types: assessments/evaluations, licensed therapeutic services, certified professional services, non-traditional community-based services, support services, enrichment services, treatment services and basic needs.
Office of Children Services	Parenting In Recovery – Family Drug Treatment Court	A program for parents who are struggling with problems of alcohol and drug addiction and are involved in the Child Protective Services Civil Court system of Travis County. The goal is to maintain children in the care of their parents while they begin the journey of recovery from addiction and develop the skills and ability to safely parent their children. The program adheres to the Family Treatment Court Best Practice Standards and utilizes the Wraparound service model.
