APPLICATION FOR HEARING ON UNLAWFUL TOWING OR BOOTING

(OCCUPATIONS CODE CHAPTER 2308.456)

The owner or operator of a vehicle that has been removed and placed in a vehicle storage facility or booted without the consent of the owner or operator of the vehicle is entitled to a hearing on whether probable cause existed for the removal and placement or booting. A person entitled to a hearing under this chapter must deliver a written request for the hearing to the court before the 14th day after the date the vehicle was removed and placed in the vehicle storage facility or booted, excluding Saturdays, Sundays, and legal holidays. A hearing under this chapter shall be in any justice court in the county from which the motor vehicle was towed; or for booted vehicles, the county in which the parking facility is located.

*Note: A person who fails to deliver a request in accordance with Occupations Code, Section 2308.456 waives the right to a hearing. *All persons should consult the Texas Occupations Code Chapter 2308 for complete information.*
