1. This notice is furnished to you as a courtesy by the Justices of the Peace of Travis County, Texas, to assist you in making a decision on the charge(s) filed against you.
2. If you wish to enter a plea of Guilty or No Contest, please indicate this decision in the proper space below. Entering either plea below indicates that you agree to waive appearance before the Court for trial by jury, waive your right to discovery under T.C.C.P. Art. 39.14, and to pay the fine stated on the reverse side of this notice.
3. If you wish to enter a plea of Not Guilty and desire a trial, please indicate this decision in the proper space below. The Court will send you notice of the trial date by mail. **YOU MUST REPORT TO THE COURT ANY CHANGES OF YOUR ADDRESS IN WRITING.**
4. **TELEPHONE CALLS OR FAX REPLIES DO NOT CONSTITUTE AN APPEARANCE BEFORE THE COURT.**
5. You may be eligible to dismiss this charge by successfully completing a Driver Safety Course (DSC) or Motorcycle Operator Course (MOTC). You will lose this right if you do not request DSC or MOTC on or before your appearance date on your citation. To determine eligibility please read the reverse side of this form.
6. Certain charges are eligible for dismissal with proof of correction and a \$10 or \$20 administrative fee. Please see reverse side for eligible charges. **YOU HAVE UNTIL THE APPEARANCE DATE ON YOUR CITATION TO SHOW THE COURT PROOF OF THE CORRECTION.**
7. **IF YOU FAIL TO RESPOND TO THE CHARGE(S) BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE MAY BE FILED AGAINST YOU FOR EITHER VIOLATION OF PROMISE TO APPEAR OR FAILURE TO APPEAR. WARRANTS MAY BE ISSUED FOR YOUR ARREST WITH A WARRANT FEE OF \$50 ADDED FOR EACH CHARGE.**
8. **IF ANY PART OF A FINE/COURT COST OR RESTITUTION IS NOT PAID WITHIN 30 DAYS OF CONVICTION, A TIME PAYMENT FEE OF \$25 SHALL BE ADDED TO THE TOTAL DUE, AS REQUIRED BY LAW.**

I request that the Court defer proceedings for 90 days so that I may complete an approved DSC or MOTC, present a uniform certificate or verification of course completion and a copy of my driving record to the Court.

*I have not completed a DSC or MOTC course to dismiss another offense within 12 months of the offense.

*I am not taking nor am I enrolled in a DSC or MOTC, nor have I completed one that is not yet reflected on my driving record.

*I certify that I have read and meet all requirements for DSC or MOTC eligibility. **See Eligibility on Reverse Side.**

*You must present this form **SIGNED** and **NOTARIZED**, along with **Court Costs (call the Court for this amount) + \$10.00 Admin Fee** and valid proof of insurance with your name on the policy to the Court on or before the appearance date on the citation. This fee is non-refundable.

*You must have a valid Texas non-commercial driver's license/permit or be a member of the U.S. Military Forces or a dependent of an active duty military member.

DRIVING SAFETY COURSE (DSC) OR MOTORCYCLE OPERATOR TRAINING COURSE (MOTC) INFORMATION

The following charges are **not eligible** for dismissal through DSC or MOTC: Speeding 25 mph over limit or more than 94 mph, Passing a School Bus, Leaving the Scene of an Accident Involving Vehicle Damage, Failure to Give Information and Render Aid, or Construction or Maintenance Work Zone offenses with workers present. **CDL holders are not eligible for DSC dismissal.**

You must enter a plea of no contest or guilty in person or by mail, pay the court costs + \$10.00 Administrative Fee with your request to take the course. It must be postmarked on or before the appearance date on the citation. **Use this form to present your plea and request - See Reverse Side.**

A certified original Type 3A driving record from Texas Department of Public Safety (Texas.gov) **AND** your original certificate of DSC or MOTC marked "Court Copy" will be required for dismissal.
