3. Once this is complete, you will see this message. This message means that the Judge has not started or admitted participants into the meeting yet, please standby.

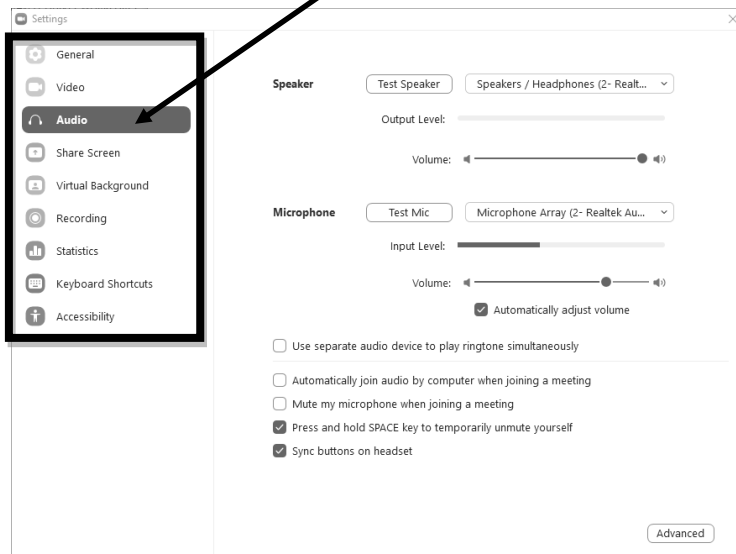
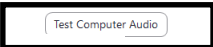
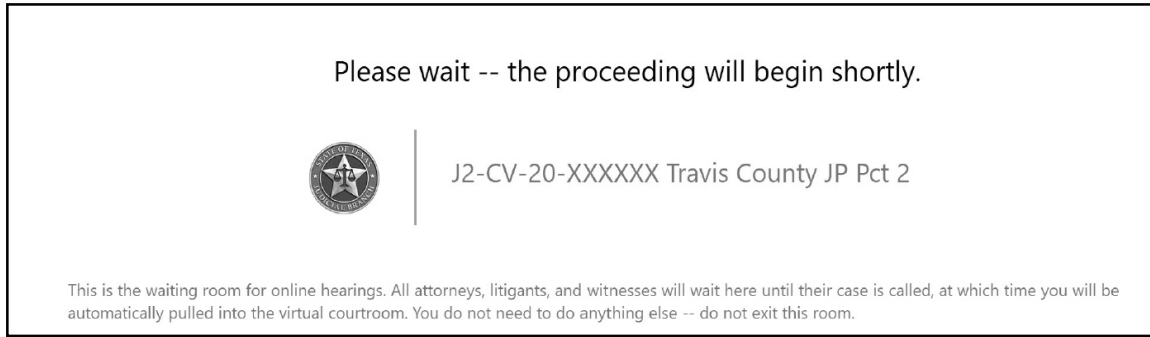
